James Dold is the Founder and CEO of Human Rights for Kids (HRFK), a D.C.-based nonprofit dedicated to protecting and promoting children's human rights in the U.S. Under his leadership, HRFK has authored or co-authored 10 Amicus Briefs, including four before the U.S. Supreme Court, and has successfully advocated for the introduction of over 80 child rights bills, resulting in 18 new laws reforming the justice system's treatment of children and child trafficking victims.

Before founding HRFK, James served as Advocacy Director and Chief Strategy Officer at the Campaign for the Fair Sentencing of Youth, where his efforts helped quadruple the number of states banning life without parole for children and led to the release of hundreds of individuals sentenced as children. As Senior Policy Counsel at Polaris Project, he spearheaded state legislative campaigns that passed 40 new anti-human trafficking laws. A graduate of the University of Maryland School of Law, James is a licensed attorney in Maryland and a member of the Supreme Court bar.



## AUDREY BAEDKE

Audrey Baedke, Strengths Cultivator at Evergreen Resilience, learned about "the life" as a young adult when a pimp recruited a close friend. She watched sex trafficking change her friend's life trajectory. Through this lens, Ms. Baedke graduated from Trinity Lutheran College with a major in Multicultural Studies, became certified as a High Fidelity Wraparound Facilitator and Coach, and gained nineteen years of experience working with survivors. She currently multiplies REST's impact by training service providers to implement promising practices and building partnerships between survivors and change makers to raise awareness and end sex trafficking.

Dunn spent 10 years in Mergers and Acquisitions, spearheading international business development in Europe and South East Asia.

In 2018, she stepped away from corporate America to Co-Found Safe House Project, a nonprofit organization dedicated to increasing survivor identification, providing emergency services, and ensuring access to safe housing and holistic care for survivors of domestic sex trafficking. Dunn is devoted to providing equitable access to services and advancing the principles of servant leadership. With a deep understanding of the systemic barriers and inequalities that prevent survivors from accessing the resources they need, Dunn has worked tirelessly to empower survivors and build a network of resources to help them heal and rebuild their lives. Through her leadership and advocacy, she has helped raise awareness about the issue of domestic sex trafficking, inspiring communities across the United States to take action to end this heinous crime. Dunn's commitment to promoting equitable access to services and her dedication to the principles of servant leadership make her a true champion for social justice.

Dunn served as a member of the Virginia Governor's Commission on Human Trafficking Prevention and Survivor Support. She has been featured in Forbes, theHill, CBN, The Pilot, Security Matters Podcast, WTKR, and more. She is a military spouse, mother of two, lifelong learner, world traveler, and protector of the vulnerable.



## SUSAN MUNSEY

Susan Munsey, LCSW, founder of GenerateHope, is a recognized leader in the fight against sex trafficking and the recovery of its survivors. Named a CNN Hero and a L'Oréal Woman of Worth, Susan has dedicated her career to helping women who have been sex trafficked rebuild their lives. GenerateHope offers a comprehensive, long-term recovery program designed specifically for female survivors, providing housing, education, psychotherapy, and adjunct therapies. Under Susan's leadership, the organization meets survivors where they are in their healing journey, offering both immediate and ongoing support.

A passionate advocate, Susan is committed to raising awareness about sex trafficking and its profound impact. She serves as the chair of the San Diego Regional Human Trafficking & Commercial Sexual Exploitation of Children (HT CSEC) Advisory Council, where she works tirelessly to drive change in her community.

Susan holds a master's degree in social work from Smith College and is a Licensed Clinical Social Worker in California. With over 30 years of clinical experience in community settings, hospitals, private practice, and as the founder of GenerateHope, she has a unique and extensive background in leadership, therapy and advocacy.

Previously, Christine was with The Salvation Army of Wake County for more than fifteen years. During that time as their Director of Social Ministries, she oversaw program operations at the Wake County Center of Hope. The programs included a 90-bed shelter for women with children experiencing homelessness; the award winning Project CATCH - Community Action Targeting Children who are Homeless; and a number of crisis assistance programs open to the community. In 2011, Christine opened Project FIGHT – Freeing Individuals Grippd by Human Trafficking. Since then, Project FIGHT has responded to hundreds of referrals across North Carolina and is located in six cities. Christine served four years on the NC Human Trafficking Commission and on The Salvation Army's North American Anti-Human Trafficking Council. In 2017, she was presented with the National Salvation Army's Excellence in Social Work award. She received her Bachelors and Masters of Social Work degrees from East Carolina University. Christine is an approved Consultant with the National Human Trafficking Training and Technical Assistance Center.

## KATHLEEN ARNOLD, MSW

Kathleen Arnold is the Senior Director of Programs for Safe House Project. With 10 years of experience in trafficking services, program development, and nonprofit management, Kathleen is a leader in the anti-human trafficking field. Before Safe House Project, Kathleen held several leadership positions in organizations focused on serving vulnerable populations, including developing and directing a safe home for children who had experienced sex trafficking. She has a proven record of developing and implementing effective programs that address the complex needs of survivors.

Kathleen is certified as a Mindset Instructor and Trust Based Relational Intervention Practitioner from TCU and gained experience in Play Therapy, Restorative Circles, and Sexual Exploitation Treatment and Training Services. Kathleen is a founding member of the Roanoke Valley Human Trafficking Task Force and Aspire, a group of allies working to break down racial and ethnic barriers to treatment and services for vulnerable populations. She was the acting chair of the Roanoke Valley Violence Prevention Council in 2020. Kathleen has a Bachelor's degree in Global Justice Studies from James Madison University and a Master's in Social Work from Radford University. Kathleen received the Excellence in Research award. She is passionate about social justice and positively impacting the lives of those vulnerable to and impacted by sexual exploitation.

## KRISTI WELLS

Kristi Wells is a leading expert in the fight against human trafficking. Kristi co-founded Safe House Project in 2017. She was inspired to take action after understanding the high volume of this criminal activity in the United States juxtaposed with the lack of safe and supportive housing options for those who have experienced trafficking.

Safe House Project has become a unifying leader in the anti-trafficking field. The organization has raised millions of dollars to support the launch of new safe homes across America for trafficking survivors, helped hundreds of victims escape their traffickers and find placement into these safe homes, and trained hundreds of thousands to spot, report, and prevent trafficking. Additionally, the Safe House Project convenes more than 500 stakeholders in the Trafficking Survivor Equity Coalition. As a human trafficking expert who regularly advises federal and state legislators and Fortune 500 companies, Kristi advances a coordinated, collaborative, public-private national response to trafficking in America.



## ZOE CHRISTINE BELLATORRE

Zoe Christine Bellatorre is a graduate of Fuller Theological Seminary with a Master's in Intercultural Studies with Children at Risk and a Bachelor of Science in Education from Ashland University. She has ten years of experience in the anti-trafficking field. Furthermore, she is a consultant with NHTTAC and the State Department Trafficking in Persons office. She has also served as the services coordinator with the Avery Center and as a survivor advocate with CAST LA and Dignity Health, responding to survivors of human trafficking in the healthcare system and providing emergency services and advocacy to patients. Zoe Christine is a subject matter expert with specific expertise in familial trafficking. In addition, she serves on the Board of Ride My Road and the advisory council of the Resilience Fund with Polaris Project.

Highlights included being published author on the TIP report in 2021, Navigating the Unique Challenges In Familial Trafficking; in the 2023 TIP report, Equity In Survivor Leadership; and in 2024, and co-author of Child Trafficking Misconceptions and the Impact of Trauma. Furthermore, she is one of the co-authors of an anthology, "Medical Perspectives in Human Trafficking In Adolescents." Christine has trained numerous professionals including healthcare systems and spoken at conferences such as the National Conference on Ending Sexual Exploitation, GRIT, Crimes Against Women, JUST, Build Beyond, and other similar presentations.

## MICHELLE GUYMON

Ms. Guymon served for 34 years with Los Angeles County, most recently as the Director of the Child Trafficking Unit with the LA County Probation Department and as project manager for the County's Law Enforcement First Responder Protocol for Commercially Sexually Exploited Children. She also chaired LA County's CSEC Integrated Leadership Team, collaborating with various county and community agencies to develop a multi-system response model. Michelle prioritizes survivor leadership in her work and has spearheaded the creation of an innovative annual conference organized by survivors for survivors.

In her retirement, Ms. Guymon leads the Special Operations Finding Kids Aftercare Team and directs Policy and Advocacy for the organization. She co-developed a gender specific intervention curriculum *Becoming Me: A Guide to Help you Heal and Grow*, for females impacted by commercial sexual exploitation, in collaboration with other survivors, and is training social workers, probation officers, mental health and foster care providers, and community advocacy agencies throughout California and across the Country. She recently returned to Los Angeles County to lead the newly created Child Trafficking Leadership Team and the 5-year strategic plan to prevent and address child trafficking.



## TOMAS LARES

Lares has over 34 years of human services experience at the local, state, and national level, managing and starting non-profits and public advocacy initiatives. He began his career in the early 90's working with the YMCA and with Big Brother Big Sisters in Polk County, Florida, where he worked with children that were being abused and exploited by their parents.

In 2004 Lares began advocating for anti-human trafficking efforts, Lares has been instrumental in developing and bringing together various task forces, coalitions, and working groups in Florida, identifying gaps, and collaborating to create solutions. In 2020, Tomas was honored by Florida Attorney General Ashley Moody as the Community Advocate of the Year. Tomas is a graduate of the Federal Bureau of Investigation Citizens Academy and was nominated as a finalist for the Orlando Sentinel's Central Floridian of the Year Award.

Drawing from her personal experience in "the Life", Ms. Morrissey seeks to help vulnerable girls avoid being recruited into the commercial sex industry and/or leave exploitation behind them. To this end, Ms. Morrissey facilitates My Life My Choice exploitation prevention groups throughout Greater Boston, as well as trains service providers in Massachusetts and nationally on recognizing the signs of exploitation and helping girls exit. In addition, she works individually mentoring girls who are victims of CSEC or are deemed high risk. Ms. Morrissey is a 2008 recipient of the prestigious Petra Foundation Fellowship and a 2012 recipient of The Philanthropic Initiative's Boston Neighborhood Fellows Award.



## ERIC MATHENY

With over 20 years in human services, including developmental disabilities, education, and workforce development, Eric is a proven leader in fostering collaboration to address complex social issues. He brings expertise in creating systemic solutions and uniting stakeholders. ## DEREK JACKSON

Growing up, I was always fascinated by the unseen—how things worked beneath the surface, how data and signals could reveal stories that most people never noticed. This curiosity led me to a career in military intelligence, where I spent five years in some of the world's most challenging environments. I worked on the front lines of information warfare, deciphering the tactics of ISIS, ensuring the safety of my team, and making critical decisions that impacted lives. The pressure was immense, but it was also a calling—a way to protect others using the power of data.

When I left the military, I thought I was leaving behind that intensity, but what I found was a new kind of battlefield—one that was closer to home. Becoming a father opened my eyes to the dangers my own children faced in the digital world.
